All reused content will be appropriately attributed to the Blog Partner. Schoolbelles may use the blog name as appropriate.

Disclaimer

The blog partnership will not begin until Schoolbelles receives the signed agreement form provided to the selected Blog Partners. Failure to fulfill the terms above will result in the termination of this service agreement. Both parties agree to respond to any communication within 2 business days, unless notified about unavailability in advance. Failure to respond within 1 week will result in the termination of the service agreement. No credits or refunds will be given for such terminations and both parties agree to these conditions.

Blog Partners represent and warrant that they will not violate any law, third party rights, or publish any false, inaccurate, misleading, defamatory or libelous content or statements. Failure to comply or if non-compliance is detected will result in the automatic termination of this service agreement.
